The external auditor report given in Section 3 of the Annual Governance & Accountability Return requires amendments as follows:

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

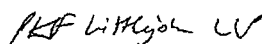
The AGAR was not accurately completed before submission for review. Information received from the smaller authority indicates that assets purchased during the prior year have not been included in Section 2, Box 9. We also note that the asset register includes VAT, as assets should be stated net of VAT the asset register should be reviewed and the prior year Section 2, Box 9 value restated in the 2025/26 AGAR.

Other matters not affecting our opinion which we draw to the attention of the authority:

In the completion of the Annual Internal Audit Report, and their detailed report, the internal auditor has drawn attention to weaknesses in relation to documenting internal controls and minuting consideration of internal and external audit reports. The smaller authority must ensure that action is taken to address these areas of weakness in a timely manner.
